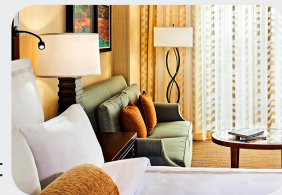

## GENERAL INFORMATION

### Reservations & Payments

Reservations may be made on-line or by phoning **(918) 254-1608 or (800) 688-8033**. Payment may be made by Visa, MasterCard, American Express, Discover or personal check. If paying by check, make checks payable to Spears Travel and mail to: **Spears Travel, 8180 S. Memorial, Echelon Center, Tulsa OK 74133**

### Special Contingency Cancellation Policy

No credit card payments will be charged unless Oklahoma wins the CFP Semi-Final Orange Bowl and advances to the National Championship Game. Upon Oklahoma advancing, credit cards will be charged immediately and all reservations will become final and non-refundable. Credit card charges will be processed by *Collegiate Athletic Travel*.

### Changes & Refunds

Once a reservation has been made, it is non-refundable (see exception above). Any name changes or changes to package arrangements made after registration will result in a fee of \$50 per change. No name changes will be accepted after January 4, 2016. No refunds will be issued for unused transportation or for other package inclusions not used by the participant unless the package can be resold.

### Game Ticket Policy

**A reserved-seat, Upper End Zone National Championship game ticket is included in all travel packages. Should you obtain tickets from other sources, a deduction of \$1,000 per person may be made from the cost of the package. No ticket deductions will be accepted after January 1, 2016.**

### Land-only Packages

Land-only packages may be purchased by those wishing to travel on their own to the destination city. Packages include all items listed as "package inclusions," exclusive of air/motorcoach transportation, airport/hotel transfers and airport baggage handling.

### Travel Insurance

Trip cancellation, baggage loss, health and accident insurance is available upon request to protect participants against unforeseen circumstances that may cause interruption or cancellation of trip as well as loss of property. Because neither Spears Travel nor Collegiate Athletic Travel are responsible for losses due to trip cancellation by participant (see following) and/or loss of luggage, we strongly recommend the purchase of appropriate insurance coverage.

### Responsibility

This program is operated under the management of Spears Travel (ST), 8180 S. ST/CAT shall not be responsible for losses or additional expenses incurred by tour participants that result from weather or mechanical related delays of aircraft or other transport modes, sickness, weather, strike, government disorder, war, acts of God, quarantine, criminal acts, or other causes. Nor does ST/CAT assume liability for personal injury, damage to or loss of personal possessions, or accidents and/or delays that result from negligence, default or "failure to perform" on the part of any subcontracted travel or service provider. All such rates provide only for arrangements as detailed in the package information. ST/CAT reserves the right to refuse to accept or retain any person as a member of the tour at anytime. ST/CAT also reserves the right to substitute comparable accommodations and transportation and to make any changes in the itinerary where deemed necessary. In the event of insufficient participation, ST/CAT reserves the right to cancel any or all parts of the tour and make appropriate refunds to the participants. Tour participants, by engaging ST/CAT and making deposit and/or full payment for the package arrangement specified, acknowledges the position of ST/CAT as stipulated by the foregoing and agrees to hold ST/CAT blameless in making the arrangements on his behalf, provided same shall be made through generally acceptable suppliers at the time of the engagement, and further agrees that restitution of damages, if any are claimed, shall be sought directly from the suppliers. The tour participant also agrees to the terms and conditions of the tour and services as set forth by the suppliers. Rates are subject to changes without notice. Tours and event tickets are subject to availability. Payment of deposit or full payment shall constitute consent of all provisions stated herein.
