RESERVATIONS & PAYMENTS

Reservations may be made online or by phoning **(800) 688-8033** or **(918) 254-1608**. All reservations will be acknowledged with a printed confirmation on a first-come, first-served basis. Full payment is due at time of booking and may be made by Visa, MasterCard, American Express, Discover or personal check. If paying by check, payment is due within 3 days of the reservation. CANCELLATIONS, REFUNDS & CHANGES

Once a reservation has been made, it is non-refundable. Any name changes or changes to package arrangements made after registration will result in a \$50 charge per change. No name changes will be accepted after December 15, 2011. No refunds will be issued for unused transportation or for other package inclusions not used by the participant.

GAME TICKETS

Game tickets are NOT included with the tour package. However, a reserved-seat Fiesta Bowl game ticket may be purchased as an option for \$175. All Fiesta Bowl tickets include admission to the Tostitos Fiesta Bowl College Football's Biggest Party.

LAND PACKAGES

Land-only packages may be purchased by those wishing to travel on their own. Packages include all items listed as "air package features," exclusive of air transportation, airport/hotel transfers and airport baggage handling.

SPECIAL CHILDREN'S PRICING

Children's rates are limited to those 17 years of age or under sharing a room with at least one adult and using existing bedding configuration (i.e., if 2 adults and a child/children occupy a room, the adults will be charged the double price and the children the child's price. If the room is occupied by 1 adult and a child/children, the adult will be charged the single price and the children the child's price.)

ROLL-AWAYS

Roll-aways may only be added to king-bedded rooms and will incur extra charges. Requests for roll-aways are subject to availability and differing fire and safety laws.

TRAVEL INSURANCE

Trip cancellation, baggage loss, health and accident insurance is available upon request to protect participants against unforeseen circumstances that may cause interruption or cancellation of trip as well as loss of property. Because neither Spears Travel nor Collegiate Athletic Travel are responsible for losses due to trip cancellation by participant (see following) and/or loss of luggage, we strongly recommend the purchase of appropriate insurance coverage.

ST/CAT reserves the right to refuse to accept or retain any person as a member of the tour at anytime. ST/CAT also reserves the right to substitute comparable accommodations and transportation and to make any changes in the itinerary where deemed necessary.
